Admission Requirements Admission to the Teacher Education Program is based on these criteria: • Complete the Praxis Core test with scores of at least 150 on the mathematics section, 162 on the writing skills section, and 156 on the reading skills section. Students with 21 or above composite ACT scores are exempt from the Praxis Core requirement. The satisfaction of this requirement is necessary for enrollment in all Teacher Education courses except TE100. • Complete TE203 Study in the Foundations of Teaching with a grade of C or above. • Complete 30 or more semester hours with a minimum 2.5 GPA. • Letters of recommendation from 1) a current professor or former teacher and 2) from a community leader or pastor. See the Teacher Education department for the questions the respondent will answer in these recommendations. • An essay covering why the student feels called to be a teacher and what the student hopes to accomplish as an educator. • An interview with two (2) faculty members and the department head. Good Standing Requirements • Candidates for the Early Childhood Development and Early Childhood Education licenses must maintain a 2.5 overall GPA with no grades below a C (2.0 per 1-hour of credit) in teacher education classes. • Candidates for the Middle Childhood or Adolescence to Young Adult licenses must maintain a 2.75 GPA in their major and concentrations, a 2.75 overall GPA, and no grade below a C (2.0 per 1-hour of credit) in teacher education and concentration classes. Probation and Suspension • Students whose GPA falls below the program minimum are placed on departmental probation the following semester. • Consecutive semesters on departmental probation will result in suspension from the program. • Students on departmental probation or suspension may not register for TE or ECE courses. • To be reinstated after probation or suspension, students must achieve a GPA at or above the required minimum.

All teacher candidates in our EPP take a course in their sophomore year which gives them a complete overview of all the exceptionalities they may encounter in their future classroom, and the methods of differentiation needed to teach students with disabilities effectively. In each methods class thereafter, our teacher candidates address these in their field placements, lesson plans, unit plans, and assessments. Our Adolescent to Young Adult majors are paired with an Intervention Specialist during their junior year to learn how to more effectively teach students with disabilities in their content area. Then, during student teaching, our teacher candidates apply all that they have learned and experienced to their classrooms and case studies.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

As stated above, our teacher candidates work with their cooperating teachers in their multiple field experiences to follow all accommodations and modifications listed on IEPs and 504s. Of course, our Intervention Specialist majors do this in all their methods courses.

All teacher candidates in our EPP take courses in their sophomore year which gives them an overview of the different methods of effectively teaching ELL and ESL students. Our Intervention Specialists take a course that specifically teaches them how to effectively teach ELL and ESL students effectively, in addition to these more general courses.

Our Intervention Specialist candidates take 48 hours of course work in their major--of these credits, over half of them involve methods hours in the field that equates to 260 hours before student teaching. During student teaching, our Intervention Specialist candidates work with their case studies and their cooperating Intervention Specialists to provide effective instruction.
